SECTION 7: Handling and storage:

7.1 Precautions for safe handling:

Only experienced and properly instructed persons should handle gases under pressure. Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Keep equipment free from oil and grease. Open valve slowly to avoid pressure shock. Use only oxygen approved lubricants and sealants.
